

Postgraduate Admissions Statement for

Application process

Online application form

Applications will not be considered until **all** required documents have been uploaded.

Required and optional documents

✓	References	We require two references including at least one academic reference. References should comply with our standard requirements outlined on our guidance pages .
✓	Degree certificate(s) and academic transcripts	From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on our guidance pages .
✓	Personal statement (Maximum 500 words)	Personal statements should highlight the motivation for applying for the course, and any relevant experience and/or skills. Further guidance can be found at; www.bristol.ac.uk/sps/study/postgraduate/applying-for-a-phd/
✓	English language certificates/other evidence	Evidence of meeting the English language profile as stated on the Postgraduate Prospectus and specified by the University English Language Requirements Policy
✓	Curriculum Vitae (CV)	CVs might include details of other relevant work experience and qualifications to support an application.

Selection process

Assessment of applications

All applicants are considered in line with the University's [Admissions Principles and Procedures Policy](#). Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Strength of academic background
- Relevance of employment/work experience (if applicable)
- Strength of references
- Fit between research background, skills, interest and the programme
- Quality of research statement/proposal
- Proficiency in English language

Interviews

Interviews form part of the selection process.

The purpose of the interview is to assess whether the applicant has the necessary skills and capabilities to pursue the chosen postgraduate programme, whether the programme is appropriate to the applicant's interests and aspirations, and to discuss the research proposal.

Interviews are normally held online.

Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission, this will be stated in the offer letter.

Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

Deferrals

Deferred entry is available for this programme subject to agreement by the relevant Admissions Team and supervisors. Please contact sps-pgadmissions@bristol.ac.uk to make a formal request.

We are open for applications and welcome new PhD students all year round. However, the largest intake is in September each year with a secondary intake in January. We strongly recommend applicants to consider a September start.

Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions. The deadline will be included in the offer letter. Offer holders who will be unable to provide their final results by this date should email sps-pgadmissions@bristol.ac.uk to notify the admissions team as soon as possible.
