Undergraduate admissions statement



This statement should be read in conjunction with the <u>University's</u> admissions principles and procedures.

Admissions process

1.1. Admissions applications

Applications should be submitted through UCAS (<u>www.ucas.com</u>) by the deadline of 15 October in the year preceding the start of the course (ie by 15 October 2016 for entry in 2017). This is the deadline set by UCAS for all applications to undergraduate medicine, dentistry or veterinary science courses. Please note that UCAS only permits four out of five choices to be used for such courses; the other choice can be for any other course or subject.

Applications are assessed by a centralised team in close co-operation with the School Recruitment and Admissions Officer(s).

1.2. Application assessment methods

Please note that the Gateway courses are aimed at specific UK Widening Participation applicants only.

All applications that fulfil the specific widening participation entry requirements for the Gateway courses (see below), and that are received on time (in accordance with UCAS deadlines), will receive equal consideration.

Applicants must be taking (or have taken) their Level 3 qualifications (eg A-levels) at a secondary school or college in the UK that fulfils the University of Bristol's Widening Participation criteria.

If necessary, priority for interview may be given to those who fulfil at least two of the following criteria:

- i) in Local Authority care;
- ii) mature (aged over 21 at the start of the course);

- iii) neither parent attended university;
- iv) applying from an address in a neighbourhood where few young people progress to higher education. This is defined using Polar3 data and a searchable database is available at <u>www.hefce.ac.uk/postcode</u>. Home postcodes with a Young Participation score of 1, 2 or 3 qualify.

Please note that those taking an Access course, all graduates, or those who have already commenced a University degree, are **not** eligible to apply for the Gateway courses regardless of their previous A-level grades or school attended.

All applicants to Gateway to Dentistry and Gateway to Medicine are required to take the UKCAT test. Details of the test, and the deadlines for application/test, can be found online at <u>www.ukcat.ac.uk</u>. Applicants to Gateway to Veterinary Science are not required to take the UKCAT.

A DBS (Disclosure and Barring Service) check will be required for all successful applicants to Gateway to Dentistry and Gateway to Medicine. This is not required for applicants to Gateway to Veterinary.

All applicants who are made an offer for a place on any of the Gateway courses will be required to complete an Occupational Health questionnaire.

Applicants are not discriminated against on the grounds of race, ethnicity, nationality, gender, sexuality, religion, disability or age.

1.3. Interview or visit day

Applicants who satisfy the academic requirements and the Widening Participation eligibility criteria will be considered for interview. This will be a series of practical tests (knowns as MMIs) undertaken at the University of Bristol; Gateway to Veterinary Science applicants will also have a face-to-face interview. Applicants invited to interview will also be given an opportunity to see relevant academic departments and be given a guided tour of the main campus or the Langford campus as appropriate. It is envisaged that for Gateway applicants these Interview Days will be held in the Spring term following application. Please also read **2.5. Interview** below.

1.4. Correspondence with applicants

All correspondence from the University relating to an applicant's status will be sent by email.

All applications are acknowledged by email on receipt (starting in mid-September), to establish contact and inform the applicant of the process to be followed.

Applicants will then be notified if their application has been successful or unsuccessful, or to inform them that their application has been assessed and put on 'Hold' pending a decision later in the cycle.

If you submitted your application by the UCAS deadline of 15 October, the final deadline by which you will receive a decision is 7 May. Most decisions will be made well before this date although we may hold some applications until later in the cycle before a decision is made.

2. Criteria for assessing applicants

To assess an application we require:

- A full academic history from age 16 onwards, including any retakes or uncompleted qualifications.
- Predicted grades for any qualifications you are currently taking. Predicted grades can only come from your school or referee. These must include an overall grade (if applicable) AND where a particular subject is specified in the entry requirements, the achieved grades or predicted grades for that subject, and any related or major subjects you are studying.

The weighted score given to particular aspects of any application that fulfils both the stated academic requirements and the essential widening participation criteria is as follows:

For Gateway to Medicine and Gateway to Dentistry:

- Personal Statement : 90%
- UKCAT score: 10%

For Gateway to Veterinary Science:

• Personal Statement : 100%

The highest scoring applicants will be considered for interview.

2.1. Academic entry requirements

Academic entry requirements for standard qualifications (A-level, IB, BTEC, Welsh Bac, and GCSEs) required for each Gateway course can be found in the <u>undergraduate course finder</u>.

Other qualifications, or combinations of different qualifications, will be considered on their individual merits; please contact the Admissions office for more information.

All applications must be submitted through UCAS; we cannot consider any direct applications to the University.

Please note that applicants who have achieved or are predicted to achieve A-level grades AAB or above are eligible to apply for the standard five-year course, and are therefore not eligible for the Gateway course. Applicants who choose to apply for the Gateway course with these grades or higher (ie above the threshold for the Gateway course) may not be considered for these courses.

However, applicants whose qualifications do not match the requirements for the standard five-year course may apply for the Gateway course and may be considered depending on the number of applications received overall: eg an applicant taking the relevant BTEC qualification but without the required Chemistry A-level will be ineligible for the standard course, but may be considered for the Gateway course if there is capacity.

Successful completion of a University of Bristol Gateway course would allow for progression onto the appropriate full five-year degree course at the University of Bristol. The Gateway

courses are not stand-alone courses and are intended only as a Widening Participation initiative for entry to the full degree offered by this University.

2.2. Additional academic criteria

All applicants must fulfil the stated Widening Participation criteria as stated in section **1.2**. **Application assessment methods** above.

2.3. Personal statement criteria

The personal statement forms a crucial part of the selection process in assessing each applicant's motivation and suitability for the course. The personal statement is assessed to see if the applicant has demonstrated:

- Professional insight: a realistic understanding of, and interest in, medicine, dentistry or veterinary science both as an academic course of study and as a career;
- Life skills and personal determination: a range of personal interests and activities (including paid work) that display an understanding of the wider community, with the ability to overcome challenges and the determination to see a task or project to a successful conclusion;
- Altruism and commitment: a sense of altruism and community involvement as demonstrated by voluntary work both within and outside school, caring responsibilities or other personal circumstances, and/or paid work, that displays characteristics such as selflessness or a practical concern for the welfare of others;
- Communication skills: a range of personal interests and activities (including paid work) that display communication skills, leadership ability and a desire to seek realistic solutions to problems and conflicts.

2.4. Reference criteria

We would appreciate referee comments regarding favourable qualities possessed by the applicant such as motivation to study, tenacity, determination, and examples of how they have overcome any challenges during their life. We would also appreciate the referee's assessment of the applicant's suitability for the professional career they have chosen.

If the referee believes the applicant's performance does not reflect their ability, due to specific educational context and/or special circumstances, the applicant should complete an extenuating circumstances form at <u>bristol.ac.uk/applicants/applied/extenuating-</u> <u>circumstances/</u>. We are unable to consider extenuating circumstances without this form.

2.5. Interview

The purpose of the interview day is to provide the applicant with an opportunity to demonstrate evidence of skills and attributes that are appropriate to a career in medicine, dentistry or veterinary science and to display insight into a range of topics related to a career in these areas. It is also an opportunity to see the facilities at the University of Bristol (at Langford for veterinary science) and speak to academic staff and current students.

For Gateway to Medicine and Gateway to Dentistry, applicants will move around a series of ten MMI (multiple mini interview) stations, each taking 5 minutes, and will be assessed on a particular criterion at each. Each station will be directed by one or two interviewers as appropriate.

For Gateway to Veterinary Science, applicants will move around a series of MMI (multiple mini interview) stations, and also have a face to face interview. Interviews are undertaken in accordance with the University's policy on equal opportunities. At least one member of the interviewing staff is trained in fair and effective recruitment, and at least one interviewer is a member of the appropriate Admissions Committee.

After interview, the applicants' performance on the MMIs (and face to face interview for Gateway to Veterinary Science) will be scored by assessors and ranked by the Admissions office. Those candidates with the strongest overall performance will receive offers. Decisions will be communicated to candidates online via UCAS.

2.6. Mature applicants

Mature applicants over the age of 21 at the start of the course are encouraged to apply. Those who are not applying straight from formal education would be expected to demonstrate recent academic study (ie. within five years of applying) or to have substantial relevant work experience. Please note that Access to HE courses are **not** accepted for admission to Gateway courses. Mature students are expected to fulfil the same academic criteria as school-leavers, including all GCSE and/or English Language requirements. Graduates, or those who have already commenced a course of University study, are not eligible to apply for the Gateway courses.

2.7. English Language requirements

All applicants are required to demonstrate that they have sufficient ability to understand and express themselves in both spoken and written English in order to benefit fully from their chosen course.

Applicants must be able to fulfil either the GCSE English Language requirement or the appropriate English Language profile if they are a non-native English speaker who was not able to take GCSEs at the appropriate time in their schooling.

English Language requirements for each Gateway course can be found in the <u>undergraduate course finder</u> and are explained at <u>bristol.ac.uk/ug-language-requirements</u>.

2.8. Contextual information

The University of Bristol has been a pioneer in the field of widening participation to Higher Education for over a decade. The Gateway courses aim to recruit able students to the University from specific under-represented backgrounds.

We take a holistic approach to assessing all applications, ensuring that an applicant's educational and social background is taken into consideration, where supported by clear evidence that this may have adversely affected academic performance, information about which can be provided in the application.

As part of our commitment to the UK national agenda on widening participation, we consider the educational context in which grades have been achieved, particularly if there is evidence that an applicant's current school or college performs below a defined threshold.

3. Offers

3.1. Typical Offers

Typical offers for A-levels and other UK qualifications can be found in the entry data in the <u>undergraduate course finder</u>. Offers to applicants with non-standard qualifications, or combinations of different qualifications (for instance A-levels and BTEC) will be made equivalent to the published A-level offer.

4. Other

4.1. Deferred applications

Deferred applications (ie applying in 2016/17 for 2018 entry) are **not** permitted.

4.2. Resits

We will consider applicants who are completing resits of GCSEs and/or A-levels (or equivalent level 3 qualifications). A maximum of one resit is allowed in any one subject.

We will only make an exception to this where there are mitigating personal circumstances (see **4.4. Extenuating Circumstances** below); the decision to allow an exception will be made at the discretion of the University.

4.3. Transfers

Applications are not accepted from those who have already started a degree either at the University of Bristol or another institution.

4.4. Extenuating Circumstances

If your education has been significantly disrupted through health or personal problems, disability or specific difficulties with schooling, or there are particular circumstances related to your personal circumstances that you wish to be taken into account when considering your application, you will need to submit an extenuating circumstances form (available at: <u>bristol.ac.uk/applicants/applied/extenuating-circumstances/</u>) to Undergraduate Admissions.

The information provided on the form will be treated confidentially, and will help us to accurately assess your academic performance and potential in light of your situation.

4.5. Policies

All applications are considered in line with our Admissions policies and procedures.

We are committed to the provision of high quality, fair and transparent admissions procedures for all our applicants. We recognise, however, that there may be occasions when applicants believe that they have cause for complaint. At this point applicants should follow our <u>Applicant feedback and complaints procedures</u>.

Should an applicant believe that University admissions principles and procedures have been inconsistently or incorrectly applied, these complaints procedures provide a mechanism for objective review.

4.6. Additional information

The University can only guarantee places if the exact terms of the offer are met, however offer holders would not automatically be unsuccessful if the terms of the offer are narrowly missed.

If offer holders do not meet the terms of their offer when exam results are released they may be considered as a 'near miss candidate'. All near miss candidates are reviewed in August after publication of A-level results.
