MINUTES OF THE 2023 ANNUAL GENERAL MEETING HELD ON 17 OCTOBER 2023

1) Welcome and introductions

- JM welcomed the attendees of the 2023 annual lecture and introduced committee officers.
- JM outlined the purpose of the London Branch and the agenda for the evening.
- JM outlined essential Health and Safety information for the venue.
- JM provided a summary of Branch activities over the past years.
- Al noted apologies from Sir Eric Thomas, who was unable to attend.

2) Minutes from last AGM and matters arising

- Papers from 2022 AGM (held in January 2023), current finances, agenda and Chairman's statement circulated.

CHAIRPERSON'S ANNUAL REPORT NOVEMEBR 2023 - OCTOBER 2024

I was appointed as chair at our last AGM meeting, held in October 2023 at the House of Lords, with Baron Jonathan Evans of Weardale, former Director General of MI5. My appointment was just for one year, taking over from Julian Metcalfe, who wished to step doe from his role a year early. The role of Chairperson is therefore due for election again this year, but I am happy to stand again.

Since our last Annual General Meeting, I am pleased to report that the London Branch of the University of Bristol Alumni Association has continued to thrive and engage our alumni community through a variety of events and initiatives.

Below is a summary of our activities and key developments over the past year.

Events and Activities:

- Carol Service (11th December 2023)
- This is always a popular annual event, held at St Vedast-alias-Foster.
- Tour of Westminster Abbey (16th March 2024)
- This event was a unique and well-received experience, with full attendance. Due to the nature of the tour, we had to limit numbers, but tickets sold very quickly. Thank you to our tour guide who provided their services free of charge
- Wine Tasting (23rd April 2024) Hosted by Mimi Avery (of this historic Averys wine cellars in Bristol), this event again sold out extremely quickly. The event was held at Champagne Charlies.
- London Walks (21st May 2024 and 24th July 2024) This is a regular annual event and is always popular, which is why we host two of them. This year's walk was around Covent Garden and Soho. Both walks were well attended. David Clark has organised these walk events for many years and we are grateful for his enthusiasm in doing these each year. This year, he has been handing over organisation to our new committee member, Kinga Grzeszczyk.
- Temple Quarter Enterprise Campus Panel Discussion and Q&A (13th May 2024) This event was a discussion and Q&A with Barra Mac Ruairí (the University's Chief Property Officer) and Palie Smart (Associate Pro Vice-Chancellor for Civic Global Engagement) about the University's plans for Temple Quarter. Although attendance was lower than expected, the attendees found it informative.
- Canterbury Cathedral Tour (12th October 2024) At this time of writing this event has not yet happened. This will include a guided tour, lunch, and an optional overnight stay in the cathedral grounds.
- Annual Lecture and AGM (8th November 2024)

We sold over 225 tickets for the above events, with 19% graduating in the last 10 years.

Financial Overview:

We have managed our finances prudently, ensuring that our events are self-sustaining while also providing value to our members and where appropriate offering subsidised tickets for more recent graduates. Thank you in particular to the Alumni Association for awarding us an Alumni Association Initiative Grant to make the Annual Lecture and AGM possible with discounted tickets for recent graduates.

As an association, we are finding London venues, in particular, to be very expensive, making it difficult for us to deliver value for money and make events accessible for everyone.
