I wrote to you on 4th November last year in connection with the above Linbury grant. At that time the Ashden trustees had not determined the amount of their support for the project; thus my letter was deliberately non-specific as to the exact amount of the Linbury grant. My colleague Jo Temple then wrote to you on 24th November to confirm that the Ashden Trust grant would be for £120,000.

I now realise that I did not write again to conform the amount of the Linbury Trust grant. I am therefore now writing to correct that oversight. The amount of the Linbury Trust grant to support the project: Assessing the feasibility and acceptability of comparing the Lightning Process with specialist medical care for CFS or ME – pilot Randomised Controlled Trial is £120,000. All other terms and conditions of the grant are as set out in my letter of 4th November.

Support from Linbury and Ashden together therefore totals the requested sum of £164,000.

I am sorry for this oversight which I understand has caused some uncertainty for your financial colleagues.
