

Bristol Continuity Calculator resource user licence

Terms and Conditions of Use

By downloading and using the Bristol Continuity Calculator you agree to be bound to the following terms and conditions:

1. University of Bristol (“UoB”) hereby grants you (“Recipient”) a royalty free non-exclusive licence to use the Bristol Continuity Calculator for the purpose of measuring continuity in general practice in the UK.
2. Except to the extent necessary for the Purpose of Bristol Continuity Calculator, the Recipient shall not sub-license, distribute, adapt, modify, translate, transfer, sell, exploit or use the Bristol Continuity Calculator in any way or for any other purpose whatsoever.
3. The Bristol Continuity Calculator or any information relating to the Bristol Continuity Calculator are provided ‘as is’ and WITHOUT ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE OR ANY OTHER WARRANTY, EXPRESSED OR IMPLIED. Neither party in particular gives nor makes any condition, other term, or provision or representation that any use of the Bristol Continuity Calculator will not infringe the rights of any person.
4. The Recipient acknowledges that any and all the copyright, trade marks, trade names, patents and other intellectual property rights subsisting in or used in connection with the Bristol Continuity Calculator shall be and remain the sole property of UoB.
