# International group with an interest in mortality of people with intellectual and developmental disabilities (v4 – updated 8.4.2020)

Below is a collation of information and resources about COVID19, submitted by members of an international group of professionals, policy makers and academics with an interest in mortality of people with intellectual and developmental disabilities.

#### **Activism**

National collaborations in the Netherlands to jointly answer Corona-related questions from care organizations for people with ID in a CoOVID19 Rapid Response (Dutch Association of Academic Collaborative Centers Intellectual Disabilities). The aim is to assist health care organizations in rapidly answering their questions related to corona and its consequences for the care and support for people with an intellectual disability. Scientists affiliated to all Dutch Academic Collaborative Centers jointly collect relevant scientific knowledge from the (inter)national literature. All questions and answers, including source evidence that will be drawn upon, will be posted in both Dutch and English on the website of the Dutch Association of the Academic Collaborative Centers Intellectual Disabilities. They are more than willing to add information from abroad.

#### Data analysis

(Maarten Cuypers, and Esther Bakker van Gijssel with colleagues, Netherlands) Has started a national prospective registry for Covid19 suspected and confirmed cases among people with ID in The Netherlands. It is financed by the Ministry of Health as an initiative of the academic collaborative 'Stronger on your own feet'. Medical specialists for people with intellectual disabilities are asked to register all corona related care and disease progression. We started to recruit care providers to enter data in our system on 24.3.2020.

(Pauline Heslop, England) Learning Disabilities Mortality Review (LeDeR) programme. The programme receives notification of all deaths associated with COVID19 of people with ID. At notification core details are collected. (Helen Leonard, Australia) Institute is encouraging of doing COVID-19 research but not sure whether they could get access to the data soon enough.

(Mary McCarron) As part of IDS TILDA they are including questions regarding COVID 19 in the end of life sections.

(Yona Lunsky, Canada) The government might be tracking information within each province for people who receive funded services from the developmental disabilities sectors.

# Questions for future data analysis

It might be helpful to consider common questions across the countries to enable us compare deaths of people from COVID19.

Concerns in Spain about people with IDD living in residential facilities. Can we find out more about deaths in residential facilities?
