Admissions Statement for Health, Law and Society (LLM)

Non-standard applications

Unfortunately, we are unable to accept non-standard applications for this programme. Applicants must meet the entry requirements.

Application process

Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our <u>guidance for online applications page</u>

Applications will not be considered until all required documents have been uploaded.

Required and optional documents

Reference: Required

One academic reference will be required as part of the application process. Professional references may be accepted if you graduated more than two years ago, or if professional experience is relevant to the application. References should comply with our standard requirements outlined on our guidance pages.

Degree certificate(s) and academic transcripts: Required

Degree certificates and academic transcripts from first and subsequent degrees must be provided. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance pages</u>.

Personal statement: Required

Personal statements should highlight the motivation for applying for the course, and any relevant experience and/or skills.

The personal statement must address the following questions (200 words max per question):

- (1) What are your motivations for studying on this programme?
- (2) How has your previous study and/or work experience prepared you for this programme?
- (3) What do you hope to achieve by completing study on this programme?

English language certificates/other evidence: Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the University English Language Requirements Policy

Curriculum Vitae (CV): Optional

CVs might include details of other relevant work experience and qualifications to support an application.

Selection process

Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Performance in undergraduate degree
- English language ability (where applicable)
- Reference
- Personal Statement

Interviews

Interviews do not form part of the selection process.

Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

Deferrals

Requests to defer the year of entry must be submitted via the applicant portal. Requests to defer should be submitted at the earliest opportunity so that it can be reviewed by the admissions team. Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by the date noted in their offer letter. Extenuating circumstances

Fees and Deposits

Fees

Annual tuition fees are available on the relevant <u>prospectus entry</u> for this programme.

Deposits

International self-funded applicants who are made an offer for a taught postgraduate programme will be required to pay a deposit to secure their place. In most cases, the deposit amount will be £2,000.

For applicants from certain regions, the University applies increased deposit requirements to help demonstrate financial credibility and to ensure compliance with UK Visas and Immigration (UKVI) regulations. In such cases, the deposit amount will typically be £15,000 or 50% of the applicant's first-year tuition fees.

The specific deposit amount required in each case will be clearly stated in the applicant's official offer letter. Information on how to pay the deposit is available on the University's website. Deposits are non-transferable and non-refundable, except in accordance with the terms outlined in the International Deposits Refund Policy.

Sponsored Students

Fully sponsored students are not required to pay the deposit but will need to upload a copy of their sponsorship letter to the online application.
