# Postgraduate Admissions Statement for Chinese-English Audio-visual Translation MA

Non-standard applications will be considered by the Admissions Tutor(s) for the programme on a case-by-case basis.

# **Application process**

## Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our <u>guidance for online applications page</u>

Applications will not be considered until **all** required documents have been uploaded.

## Required and optional documents

#### References: Required

One academic reference will be required as part of the application process. Professional references may be accepted if you graduated more than two years ago, or if professional experience is relevant to the application.

References should comply with our standard requirements outlined on our guidance pages.

#### Degree certificate(s) and academic transcripts: Required

From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance pages</u>.

#### **Personal statement: Optional**

Personal statements are not required for this programme as they do not form part of the routine application assessment process. However, applicants are welcome to submit a personal statement, as an additional document, if they wish to do so, to provide additional context and detail about their relevant experience and achievements.

#### English language certificates/other evidence: Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English Language Requirements Policy</u>

## **Curriculum Vitae (CV): Optional**

CVs might include details of other relevant work experience and qualifications to support an application.

#### Supplementary requirements

Non-native Chinese speakers, without a degree in Chinese/Mandarin will be required to complete a translation test and possibly a Zoom/Teams interview as part of the application process. The applicant will be notified if this applies.

## **Selection process**

## Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Performance in undergraduate degree
- English language ability (where applicable)
- References
- Translation test (where applicable)
- Interview (where applicable)

#### **Interviews**

#### **Decisions**

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

### Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

## **Deferrals**

Requests to defer the year of entry must be submitted via the applicant portal. Requests to defer should be submitted at the earliest opportunity so that it can be reviewed by the admissions team. We cannot guarantee that requests will be granted. #### Results deadline
