International Foundation Programme (IFP) for Medicine

1. Admissions process

All applicants are considered on an equal basis in line with the University's Equality and Diversity Policy.

Applicants are asked to complete an online application form (available on eVision) and upload the required supporting documents: UKVI IELTS Certificate, high school graduation certificate and transcript (or predicated grades), a personal statement, and a copy of their passport.

All applications are considered by the Admissions Team who assess the qualifications and personal statement for evidence of:

- Academic and English language achievements and potential.
- Interest, motivation, and commitment to the programme

The University is committed to creating a diverse learning environment where all students are valued for their individual differences and contribution, with equal opportunities for all irrespective of age, disability, race, sex, gender reassignment, marriage or civil partnership, pregnancy or maternity, religion or belief, and sexual orientation.

Eligibility criteria

The International Foundation Programme (IFP) for Medicine is designed for overseas students (non-UK students) wishing to enter medicine (MB ChB/ MBBS) degree programmes in the UK, including at the University of Bristol, but whose national secondary school leaving qualifications are currently insufficient without additional study.

The IFP for Medicine is not intended for overseas students who already have, or are studying towards, qualifications which are listed as acceptable for entry to medicine (MB ChB/ MBBS) degree programmes in the UK. For more information on accepted qualifications please see:

All university graduates and those who have already started a university course, including a foundation course, are not eligible for the IFP for Medicine, regardless of their previous secondary school grades.

To be eligible, the applicant must:

- Demonstrate excellent overseas secondary school grades in the sciences, one of which must be Chemistry or Biology.
- Have a UKVI approved overall IELTS band score of 7.0, with no individual component band score below 6.5 (taken within 2 years of the date of course commencement).

Aspirational offers

Due to the competitive nature of this programme, we will only consider applicants who are predicted to achieve (or have already achieved) the entry requirements in full.

Minimum age requirement

Students must be at least 17 years of age by 1st September of the year that they enter the IFP for Medicine. This is to ensure that all students progressing onto an undergraduate medicine (MB ChB/MBBS) programme will be 18 years of age (or above) at the point of entry, have the legal capacity to be bound by the rules of confidentiality of our NHS partners, and are able to undertake clinical experiential learning in our teaching general practices and clinical academies.

Person statement criteria

Given the large number of applications we receive, we necessarily place emphasis on the quality of the personal statement.

For their personal statements applicants should answer the following questions:

- Why do you want to study this course or subject?
- How have your qualifications and studies helped you to prepare for this course or subject?
- What else have you done to prepare outside of education, and why are these experiences useful?

As a guide you should write approximately 200 words per question.

Interviews

Based on the application and required supporting documents, applicants will be shortlisted and considered for interview as part of the selection process. Interviews are conducted remotely via video calls, with a small panel of staff which will include the IFP Programme Director or equivalent, and at least one other member of staff who has been trained in fair and effective recruitment techniques and are undertaken in accordance with the University's policy on equal opportunities.

The following criteria will be considered when assessing the interview performance:

- Academic achievement and potential.
- Interest, motivation, and commitment to the programme.
- Communication skills.

Applicants who are unable to attend their interview will be offered a second and final opportunity to attend an interview. Students who do not receive an offer post interview are not eligible to retake their interview.

UCAT

All applicants are required to take the University Clinical Aptitude Test (UCAT) in the same calendar year as submission of the UCAS application. For example, if submitting a UCAS application in October 2027, the UCAT test must have been taken in the July to September of 2027. We accept scores from both the UCAT and the UCAT ANZ for admission to our undergraduate medicine programme. International Foundation Programme for Medicine students are guaranteed an MMI interview at the University of Bristol, and so UCAT scores are not used as part of this process. However, applicants are still advised to sit the UCAT as this score will be used by other UK Medical Schools as part of their admissions process.

We strongly advise candidates to take the test as early as possible should there be any ongoing circumstances which may mean they will need to reschedule a test (e.g., illness). If any problems occur when taking the test, you must contact Pearson (UCAT) directly.

Applicants sitting the UCATSEN are no longer required to provide the University with evidence of their eligibility. This must be submitted directly to UCAT. Further information can be found on the UCATSEN website: <https://www.ucat.ac.uk/ucatsen-evidence>

Criminal records check

All students entering the IFP for Medicine must undergo a Disclosure and Barring Service (DBS) check, and where necessary an international police check.

Applicants with a disability

We make no reference to any information disclosed regarding disability when reviewing applications and inviting applicants to interview. If you are invited for interview and feel that your disability means that you would benefit from an adjustment to our interview process, we would be happy to consider what reasonable adjustments might be applied.

Mature applicants

Mature students (those aged 21 and over) receive the same consideration as other candidates.

Deferred applications

Deferrals will not be allowed. Applications will only be considered in the cycle in which they are submitted, and under the policies in place for that cycle.

Resits

Students who have completed resits of their secondary school examinations will be considered for admission to IFP for Medicine.

Transfers

Transfer requests from one Foundation Programme within the UK to the University of Bristol IFP for Medicine will not be considered.

Admissions team

Applications are received by the Faculty and approved by the Programme Director or nominee.

Admissions process

We assess applicants based on their application, required supporting documents and interview only. We do not take into account any additional information received from an applicant or institution, unless we have requested it.

Applications received before the deadline are guaranteed equal consideration. Applications received after the deadline will not be considered unless previously arranged through sponsor agreements or additional places become available.

To assess an application, we require the following documents:

- Online application
- IELTS certificate
- High school graduation transcript or predicted grades
- Personal statement

- Copy of the applicant's passport

Applicants who satisfy the entry requirements will be offered a pre-offer interview as part of the selection process.

Conditional offers will be made for those applicants who have not received their final school grades or IELTS. However, all applicants must fulfil all offer conditions to be issued an unconditional offer and be eligible to register on the IFP for Medicine.

Once a decision has been made, the applicant will be informed of the outcome by email. Applicants will have one month to accept their offer via the application portal, and must supply any required supporting documents by the 1st August of that year.

The offer letter will include information on how to pay the deposit and subsequent steps of the admission process.

Correspondence with applicants

All correspondence relating to an applicant's status is sent by email. If an applicant nominates an agent, we will also send correspondence to the agent once an agent authorisation form has been completed and submitted. If the contact details change, we ask applicants to inform us by email: medicine-ifp@bristol.ac.uk.

International applicants

Only international (non-UK) applicants are eligible to apply for this programme. There is one standard fee for the IFP for Medicine, regardless of whether students are eligible for home or international fees (e.g. under the Ukraine schemes), or whether they are self-funded or financially sponsored. The fees for subsequent undergraduate courses following successful progression from the IFP for Medicine would then be set at the appropriate course fee.

English language requirements

Applicants must have a valid (taken within 2 years of the date of application) overall IELTS band score of 7.0 with no individual component band score below 6.5. It is expected that a student enrolling on the IFP would have an IELTS band score of 7.0 overall and would progress to IELTS band score 7.5 overall during the programme (as would be required for acceptance on to Bristol Medical programmes). Deposits

International students are required to pay a deposit of £2,000 to secure their place on the programme.

For sponsored students, receipt of a Financial Guarantee Letter (FGL) replaces the deposit requirement and acts to secure your place on the programme. Sponsored students who choose to pay the deposit to secure a place on the programme ahead of receiving a FGL, will be eligible for a deposit refund once a FGL is received.
