Academic requirements	<p>Applicants must hold/achieve a minimum of; An upper second-class honours degree in law (or international equivalent).</p> <p>Exceptionally, we will also consider applicants who have:</p> <ul style="list-style-type: none"> an upper second-class honours degree that included content relevant to the applicant's proposed field of study; or an upper second-class honours degree in any subject, along with relevant experience in a discipline closely related to the focus of this programme. <p>Applicants in either of these two exceptional cases must make a case explaining why their qualifications or experience fall into category (1) or (2) in their personal statement.</p> <p>Recognised Prior Learning is currently not accepted. Previous or professional experience is not required.</p>

Application process

Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our [guidance for online applications page](#)

Applications will not be considered until **all** required documents have been uploaded. If you have already submitted an application, you can upload additional documents into the 'Post-submission uploads' section of the application form. Paper documents received by post, or electronic documents received by email, are only considered in exceptional circumstances.

Required and optional documents

✓	Two academic references (minimum):	<p>References should be submitted electronically by the referee, using the online reference form. Alternatively, scanned copies of the original reference document(s) can be uploaded by the applicant.</p> <p>If you graduated more than five years ago, or if professional experience is relevant to the application, professional references will be accepted in lieu of one academic reference. At least one referee should be familiar with the applicant's academic work.</p> <p>References supplied with a personal contact email address will be accepted in exceptional circumstances, which must be explained within the reference.</p> <p>All references must be written, signed and dated on official letter headed paper from the referee's organisation. They must include the referee's full contact details, i.e. postal address, telephone number and organisation email address and must be dated within the last two years. A reference template is available to show the required format.</p>
✓	Degree certificate(s)	<p>From first and subsequent degrees. We require colour scans of original documents and certified translations of documents issued in any language other than English.</p>
✓	Academic transcripts	<p>From first and subsequent degrees. We require colour scans of original documents and certified translations of documents issued in any language other than English.</p> <p>Transcripts must list all subjects taken and grades achieved to date, with the grade scale clearly displayed in the transcript. Applicants must clearly state their current average grade in the online application form.</p>
✓	Personal statement:	<p>Personal statements should highlight the motivation for applying for the course, and any relevant experience and/or skills.</p>
✓	English language certificates/other evidence	<p>All applicants are required to have reached the required profile level of English language as specified by the University's English Language Requirements Policy</p>
Optional Documents		<p>Curriculum Vitae CVs might include details of other relevant work experience and qualifications to support an application.</p>

Selection process

Assessment of applications

All applicants are considered in line with the University's [Admissions Principles and Procedures Policy](#) and [Equality, Diversity and Inclusion policy](#). Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- performance in undergraduate degree
- English language ability (where applicable)
- references
- personal statement

Interviews

Interviews do not form part of the selection process.

Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

If an applicant is not selected to receive an offer for the course to which they have originally applied, we may offer the opportunity to be considered for an alternative programme in a related subject area. In such cases applicants will receive an email notification providing any alternative course options and asking whether they wish to be considered for these. It may be necessary for applicants to submit additional documentation in order for the application to be fully considered for an alternative programme. Details of the documentation required can be found in the admissions statement for the relevant programme.

Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by **1 August 2020**. Offer holders who will be unable to provide their final results by this date should email law-pg-admissions@bristol.ac.uk to notify the admissions team as soon as possible.
